# Minutes - Tuesday, October 8, 2024

#### 24/218 Councillors present

#### 24/219 Apologies for absence

# 24/221 To receive and approve minutes of last meeting

Councillors approved the minutes of the meeting on September 10, 2024.

#### 24/223 County Councillor report - Cllr Dominic Fairman

Cllr Fairman spoke about the congestion scheme and Cornwall Council's correspondence about the siting of the table near the school (they would prefer to put it the West Downs Road side of the school). Councillors discussed the reasons for having it the playing field side of the school – if it is the other side, that will give vehicles a chance to speed up; two thirds of the traffic goes through the village from Rockhead to West Downs and the principle reason for the scheme is traffic calming; it would provide a safe crossing for people dropping their children to school; it will slow traffic down. Cllr Fairman will go back to Cornwall Council with the responses.

#### 24/226 Correspondence

The following correspondence was noted: Community Area Partnership survey; Community Area Partnership draft action notes from previous meeting; Forest for Cornwall newsletter; Community Area Partnership meeting agenda (October 21 at Bodmin); Framework for Leisure briefing slides; Cornwall Council affordable housing newsletter.

#### 24/227 Bettle & Chisel

Graeme Bunn (Red Oak's Property and Acquisitions Director) and Jake Russell (CPC) attended to speak to the council about proposals for land behind the Bettle & Chisel. Graeme said Red Oak obtained the pub through a transaction with St Austell Brewery, in which they purchased 17 small, wet-led village pubs. They looked at the Bettle & Chisel pub car park and due to its substantial size, have had discussion on how to utilise the car park to be able to invest in the pub. They have found a new tenant, and it is envisaged that the pub will be open by the end of October. Jake circulated some plans and drawings and said there is a lot of land with high maintenance costs. They propose eight three-bedroom houses on land not needed (outbuildings are surplus to requirement). He realised vehicular access is tricky and they have come up with a one-way arrangement in the car park. An application has been submitted to Cornwall Council but they are happy to tweak the plans if necessary. Cllr Ferguson asked if the properties would be of a price that would only attract second home owners. Jake said they are finding Cornwall Council is putting in conditions such as that the properties must be occupied for an extended period of the year. Cllr Cann asked if any would be classed as affordable housing. Jake said they fall under the threshold of having to provide any affordable housing (ten units). He said they could have squeezed to ten to provide affordable housing, but it would have been too cramped. All will be placed on the open market. Graeme explained there will be two areas of car park – a pub car park and residents' car park. He was asked about the residents of High Street who currently park in the pub car park, but he said they have no parking rights at the moment. Cllr Ferguson said the entrance is opposite a zebra crossing. Jake said by removing the outbuildings, and introducing a stop and wait arrangement, it would make access easier. However, it was noted by councillors that if there are eight houses there, there would be traffic in and out every day. Cllr Chapman highlighted the issue with on-street parking in the village already. Graeme said it is a private car park. The company has reached out to the residents on the three nearby cottages and none have indicated they want a permanent right to park their car there. Cllr Fairman said the second home condition (restrict to primary residence) is not mandatory but the parish council could request this when the application comes out for consultation. Cllr Fairman asked if they were aware of the phosphate issue locally. There is no indication on price of properties yet. They were questioned as to why they are all three bed and not, for example, one bedroom flats. Jake said it was not considered the right site for one bed properties. Cllr Cann asked if the properties didn't sell on the open market, would they consider selling to a housing association. Graeme said that had not yet been contemplated. The council thanked both for attending the meeting.

#### 24/228 Playing field swings

The council received an email requesting that the bars on the swings are changed to chains so the children can twist them round and spin. Councillors noted that, as well as health and safety, Delabole Parish Council has not changed the links, the bars have been there for a long time. The clerk will reply.

#### 24/229 Railway track

Councillors received correspondence about turning the former railway line into a walking trail. It was noted that a group of residents looked into making it a cycle track to Camelford in the past, but it was not possible. The council agreed it would be a lovely idea and if the resident is keen, they are welcome to investigate it.

#### 24/230 Seaweed Farm

A copy of the latest correspondence was presented to the council. Cllr Cook said the lawyer working for the group has given the opinion that the MMO may be duty bound to reopen the investigation, as it has received over 500 letters.

# 24/231 Skatepark / pump track

Jo Harris and Zoe Burnard attended on behalf of the skatepark committee. The councillors were provided with the plans for a pump track, which would be considerably cheaper than a skatepark. Jo confirmed that a new planning application would need to be submitted if plans were to go ahead. Councillors said that as it is a new project in essence, support and the funds would have to be re-voted on. A public consultation would also be needed to see if the residents are keen on the pump track plans and the council giving a sum of money towards it. A piece will be placed in the Slate and on Facebook to generate as much feedback as possible.

# 24/232 Dog waste bin

A request was received for a dog waste bin at the Trebarwith Road end of the village. The clerk will contact Cornwall Council to see if they are able to provide one. If not, the parish council can look at it during the budget discussions.

#### 24/234 Pavilion

A lease for the sports pavilion will be deferred until November.

#### 24/235 Stile

The clerk has contacted Cornwall Council and is awaiting a reply. It will be placed on the November agenda.

No update from Cornwall Council. Ben Maguire, North Cornwall MP, has agreed to get involved.

# 24/237 Cornwall Air Ambulance grant request

Councillors agreed to give a donation of £100.

#### 24/238 Green Lane / Atlantic Road

The council received a reply from Cornwall Council about the unity authority adopting roads (would only consider if in a good condition). Cllr Fairman said he has spoken to someone from Cornwall Council and they have agreed to put in some plainings. There is also a document that could suggest that the path needs to be maintained. He will forward a copy to the clerk. Cllr Ferguson said it had been brought up that it was not accessible to the fire brigade, but the Delabole firefighters did their training last week and got up there with no problem.
