Minutes – Tuesday, January 14, 2025

25/1 Councillors present

Cllrs H Ferguson (chair); K Cann (vice chair); A Stacey; A Pengelly; J Chapman; C Bailey; A Pooley; P Cook and P Martin. Also in attendance: Cllr Fairman; S Cleave, clerk and four members of the public.

25/2 Apologies for absence

25/4 To receive and approve minutes of the last meeting

Councillors approved the minutes of the Ordinary meeting held on December 10. 2024.

25/6 County Councillor report - Cllr Dominic Fairman

Cllr Fairman said he had submitted a piece for publication in the Slate about the implications of the government planning ambitions on planning in Cornwall. The number of units in Cornwall to be developed has doubled. He said the local plan no longer has any weight, but instead it will be judged on national policy and sustainable development. However, currently, Delabole is still wrapped up in the neutral neutrality issue.

25/7 Clerk's report

The clerk's report was noted. She will forward any dog fouling evidence to Cornwall Council.

25/8 Consideration of planning applications

PA24/08088 – Retrospective change of use of land to campsite, with access, parking, landscaping and associated facilities buildings. Blackthorn, Vell Lane, Delabole.

The council voted to object to the plans. This was on the following grounds:

- * On the application, there is no mention of owner accommodation. However, it states permission for six caravans when there is a licence for five. The parish council received a letter from Cornwall Council last year which stated there is no permission for owners to stay on site.
- * The plot of land was advertised and sold as agricultural land. This change of use makes is business use. Hs an environmental impact assessment been carried out regarding the change of use?
- * There are livestock on the site. We are aware that some of these need to be reaistered.
- * There was a recent application for a campsite on Treligga Downs Road. Although this is in Delabole, it falls within the Tintagel Parish Council boundary. We note that this application was refused. This application (PA24/08088) has similar aspects. These include the access and it encroaches on the National Landscape designation. It is not infill. It is contrary to Cornwall Policy number 5.
- * Delabole already has a campsite, and there is another situated between Delabole and St Teath. Do we need another?
- * There are also concerns over sewage and the amount of discharge going into the main sewerage system. Delabole is also included in The River Camel

Phosphate Issue, so this has an impact on those restrictions.

* Access problems have also been highlighted. Access to the site is down a narrow single track, not suitable for caravans and large vehicles.
